

ATTORNEYS IN LYON CONSULAR DISTRICT

Definition:

AVOCATS An "avocat" must be a lawyer or attorney. "Avocats" may render legal advice on all matters, draft agreements and contracts, handle commercial disputes and collection cases, and plead and defend civil and criminal cases before the French courts to which they are admitted.

NOTARIES (NOTAIRES) A French "notaire" is a public official appointed by the Ministry of Justice, and not the equivalent of a notary public in the United States. The number of "notaires" in each jurisdiction is limited, and their fees fixed by law. Their functions include the preparation and recording of notarial acts (wills, deeds, acts of incorporation, marriage contracts, etc.), the administration and settlements of estates (excluding litigation in court) and serving as the repository of wills. They are not lawyers, but very specialized members of the legal profession. They may not plead in court.
